Class Regulations

1. Required Range Equipment:
 - a. Eye Protection — Safety glasses, prescription or types purchased at sporting goods store, etc.
 - b. Ear Protection — Ear muffs designed for shooting or the foam/sponge ear plugs.
 - c. Baseball cap or hat with a brim.
 - d. Handgun (see regulations on the first page of the application). Caliber .22 up to .45. It must pass a safety inspection.
 - e. Ammunition — a minimum of 50 rounds in the caliber for your handgun. They must be factory loads.
2. General
 - a. The Instructor may remove any student at any time from the class or from the Range for any action or activity that the Instructor deems unsafe or inappropriate.
 - b. Dress appropriately for the weather—remember the range portion is conducted outside.
 - c. No alcohol or drugs! Any prescription or non-prescription medicine that advises against driving must not be taken prior to going to the range/shooting.

Class Information

1. Unless otherwise stated, the Saturday license class begins promptly at 8 am. (Please check with instructor for Range Qualification times or other start times/days.) Please arrive a few minutes early. This is an 6-hour class (CLEET regulation). the Range Qualification may take up to two hours.. Depending upon the number of people in the class, we may finish a few minutes early or late! We do have a short drive to the range.
2. The Range Qualification (Live Fire portion) will require a short classroom session before going to the range. We will meet at the above address unless otherwise noted. Please check with the instructor as to the exact time.
3. You will be furnished a copy of the SDA Law Book, and class notes in a notebook, but you will need a pen or pencil to take additional notes, a highlighter (color of your choice), and a pencil with a good eraser for the exam.
4. For those taking the full class, a Certified Professional Photographer will take your passport-style photo and furnish you with a digital file in the correct size for upload to the OSBI application on their web site. **This is included as part of your class fee.** Bring a USB flash drive or we have one for \$5. Traditional passport prints are available for an extra fee.
5. Coffee will be provided and water is available, but if you wish something else feel free to bring your own drinks. There is a refrigerator to keep them cold and a microwave to heat them up if necessary.
6. We will take a 30-minute break for lunch. **The full-day class now INCLUDES lunch.** If you desire, bring your own sandwich (or lunch items), you may keep your lunch in our refrigerator.
7. Bring your handgun in a case or range bag—but **DO NOT BRING AMMUNITION INTO THE CLASSROOM.** The instructor will inspect your handgun during the lunch break or prior to the Range Qualification. Store your ammunition separately until we arrive at the range and you are instructed to bring it out.
8. Since we will be using an outdoor firing range, the instructor may reschedule the range time due to inclement weather or rain. If you need to schedule a separate range time be sure to visit with the instructor prior to class.
9. If you have not fired a handgun before or you feel you need additional coaching, the instructor may offer the NRA Pistol Orientation Class prior to the SDA class. Please check with him as to the schedule or individual coaching.
10. Additional classes are offered for those who wish to gain a better mastery of their firearm. The NRA Basic Pistol part I (Phase I) is offered as an online class directly by NRA (www.nrainstructor.org) and Phase II, the demonstrations, review and shooting portion is offered periodically at our facilities.

You may rent a semi-auto for the qualification (includes ammunition). If you do not currently own a pistol, then it may be best to rent one for the class instead of buying one at this time.
